My InnerView each year surveys hundreds of thousands of nursing home residents, families and employees across the country in four specific areas pertaining to their nursing home: overall satisfaction, quality of life, quality of care and quality of service.

To ensure accuracy, responses are anonymous and kept confidential. The survey is voluntary, and nursing homes are not named in the overall results, but individual facilities do have access to results so they can see how they measured against other facilities and for quality improvements.

The survey is designed to provide a snapshot of the profession as a whole.

My InnerView chose its Excellence in Action award winners based on responses from the 2008 survey process. Facilities had to achieve a minimum 30 percent response rate, and score in the top 10 percent when participants were asked if they would recommend their nursing home to others as a place to live or work. Only 520 of the nation's nearly 16,000 nursing homes received the recognition.

PHCA is a statewide advocacy organization for Pennsylvania's most vulnerable older residents and their providers of care. Members comprise for-profit and nonprofit providers. PHCA, along with its sister agency, the Center for Assisted Living Management, represents more than 330 long-term care and senior service providers that care for almost 38,000 elderly and disabled individuals.
